



VERIFICATION OPINION DECLARATION GREENHOUSE GAS EMISSIONS AND ENERGY DATA

To: Stakeholders of Dolby Laboratories, Inc.

Apex Companies LLC, (Apex) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions and energy data reported by Dolby Laboratories, Inc. (Dolby) for the period stated below. This verification opinion applies to the related information included within the scope of work described below.

The determination of the GHG emissions and energy data is the sole responsibility of Dolby. Dolby is responsible for the preparation and fair presentation of the GHG emissions and energy data statement in accordance with the criteria. Apex's sole responsibility was to provide independent verification on the accuracy of the GHG emissions and energy data reported and on the underlying systems and processes used to collect, analyze, and review the information. Apex is responsible for expressing an opinion on the GHG emissions and energy data statement based on the verification. Verification activities applied in a limited level of assurance verification are less extensive in nature, timing, and extent than in a reasonable level of assurance verification.

Boundaries of the reporting company GHG emissions and energy data covered by the verification:

- Worldwide

Data and information supporting the Scope 1 and Scope 2 emissions and energy data assertion were generally historical in nature but were in some cases estimated. Data and information supporting the Scope 3 GHG emissions data assertion were in many cases estimated rather than historical in nature.

Criteria against which verification was conducted:

- World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD) Greenhouse Gas Protocol, Corporate Accounting and Reporting Standard (Scope 1 and 2)
- WRI/WBCSD Corporate Value Chain (Scope 3) Accounting and Reporting Standard

Reference Standard:

- ISO 14064-3 Second Edition 2019-04: Greenhouse gases -- Part 3: Specification with guidance for the verification and validation of greenhouse gas statements

Level of Assurance and Qualifications:

- Limited
- This verification used a materiality threshold of +/-5% for aggregate errors in sampled data for each of the above indicators.

GHG and Energy Data Verification Methodology:

Evidence-gathering procedures included but were not limited to:

- Interviews with relevant personnel of Dolby and their consultants;

- Review of documentary evidence produced by Dolby;
- Review of Dolby data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions and sustainability data; and
- Audit of sample of data used by Dolby to determine GHG emissions and sustainability data.

Verification Opinion:

Based on the process and procedures conducted, there is no evidence that the GHG emissions and energy data statement shown above:

- is not materially correct and is not a fair representation of the GHG emissions and energy data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2), and WRI/WBCSD Greenhouse Gas Protocol Corporate Value Chain Accounting and Reporting Standard (Scope 3).

It is our opinion that Dolby has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions and energy data for the stated period and boundaries.

Statement of independence, impartiality and competence
