- Total energy consumed: 63,579.6 GJ.
- Dolby matched 100% of global electricity consumption with renewable electricity in FY25, in alignment with RE100 guidance. Our renewable energy claim is verified by an independent, third-party; the verification statement is on our website.

TC-SI-130a.2: (1) Total water withdrawn, (2) total water consumed, percentage of each in regions with High or Extremely High Baseline Water Stress.

- Total water withdrawn: 18,265 cubic meters.
- Total water consumed: 2,801 cubic meters.
- 8% withdrawn and 5% consumed in high-stress regions.
- Water use occurs in office environments, and data coverage is 67% of the real estate portfolio.
